One of the most enduring aspects of the Holmesian Canon was Sidney Paget's drawings for the Strand. He was one of 18 artists contributing illustrations for the initial publishing. Perhaps Mr. Paget and Frederic Dorr Steele, illustrating for Collier's in the US are the most famous artists sketching the Sherlockian characters. Mr. Paget used his brother Walter as his model for Holmes; ironically, Walter, also an artist, was the first choice of the editors of the Strand, but some sort of mistake was made and the offer went to Sidney instead.

But could anyone imagine another artist rendering the fine drawings made by Mr. Paget? In his illustrations, you can almost feel the gloom settling over Baskerville Hall or hear the water cascading down Reichenbach Falls. His drawings are wonderful creations of "men of note" fighting evil at every turn, saving the falsely accused and helping the downtrodden.






