The Meiringen Chamber of Commerce issued a statement today expressing its condolences to the families of one Sherlock Holmes and one Professor James Moriarty. GLORIA SCOTT DISASTER QUIBBLED OVER

ACCUSATIONS HURLED

MEN SAY SILLY THINGS

Hugh Grimesby-Smythe, spokesman for Peter Carey Ship Builders Limited, said today that his company was in no way at fault in the recent explosion of the *Gloria Scott*. "The fault can be traced to faulty gunpowder," he said.

But Trent Lattimore, executive director of Booming Industries, a division of Moriarty Enterprises, LLP, said, "Our gunpowder is the safest gunpowder in the world. It is so safe that nothing can make it blow up. Therefore, it must have been something else that caused the ship to explode. Perhaps the food or maybe the lavatory."

But William Williams, of Culverton Smith's Pies and Things, Inc., said that the food they prepared for the barque was fresh, nutritious and tasty. "Nothing could have exploded—not even the tomatoes."

Lawrence Winter, owner of Lavatories by Larry, said the idea was preposterous. "All of our facilities are completely safe—completely. They are benchtested dozens of times before they are installed. There is not one square of evidence that our lavatories are to blame."

Meanwhile, according to Scotland Yard, the investigation has ground to a halt. "Mostly because the ship is at the bottom of the ocean half a world away," Lt. Simon Cushing said.

SCOTLAND YARD ISSUES APOLOGY INSPECTOR CALLED "CLUELESS"

Other witnesses report that the two gentlemen descended from their cabs and circled one another, still hurling invectives. By the time police arrived, the two had thrown several punches at one another. Dr. Roylott's eye was swollen, and Mr. Rucastle's mouth was bleeding. Police arrested them both for blocking traffic and generally behaving like five-year-olds. ("That's a real offense what's on the books," Sergeant Ryan Cornelius said. "It's a wonder what we don't have more five-year-olds locked up.")

Attorneys for both men obtained their releases within hours of their detention. And both attorneys attempted to downplay the incident.

"Dr. Roylott is under great personal strain," Leeds Coventry said. "He recently injured himself with a fireplace poker and was on his way to a surgeon."

"Mr. Rucastle," according to Mallow Duncan, "prefers the company of his family and does not do well in social situations. The incident has greatly contributed to his declining health."
