Sherlock Holmes and the Underpants of Death

This is an anthology of six parodies, five novellas and one short story. The humor is definitely modern British and is a mixture of what Americans would recognize as middle-school salacious and British would describe as Public School potty (if not worse). For American readers unfamiliar with modern British slang, much of it is completely impenetrable and that, at least, is a blessing. I was only able to finish the first three pieces and part of the fourth, and those only with great effort. After flogging myself for almost two weeks to complete the book, I surrendered to my cowardly impulses and decided to write a review based on what I had read.

On the basis of the first three pieces, the book is a waste of time unless the reader is 'into' one of the types of humor described above. If you like that sort of thing, then this book is your meat and potatoes, or poison, as the case may be. As must be apparent, I do not enjoy titillation and toilet humor, nor do I have a taste for snicker material or political satire written for adolescents. The book contains a good deal of both items, continuing on and on and...

The stories are, in order of emergence; "Sherlock Holmes and the Underpants of Death," a gross parody of HOUN, "The Mystery of the Hidden Turd," an unmentionable mystery, "The Problem of the Poultry Affair," a paltry effort, "The Adventure of the Lingering Stench," which left a bad taste, "The Experience of the Quickest Client," the lone thankfully short parody, and "The Conundrum of the Missing Motherfucker," a definite Freudian slip. The stories often live up to their titles and are strewn about with strange characters, mostly Holmes and Watson.

BARITSU?

"When I reached the end I stood at bay. He drew no weapon, but he rushed at me and threw his long arms around me. He knew that his own game was up and was only anxious to revenge himself upon me. We tottered together upon the brink of the fall. I have some knowledge, however, of baritsu, or the Japanese system of wrestling, whish has more than once been very useful to me."

If you were to try a search for the art of baritsu, you would fail, save for the question of whether or not you meant to search for 'bartitsu' perhaps? The answer is unequivocally yes.

Whether it was an error on the part of Doyle or Watson or the printer, bartitsu is the proper term of the self defense method mentioned by Holmes. This method was developed by an Englishman ahead of his time, Edward William Barton-Wright, in 1898. A British Engineer, Bartonright lived for three years in Japan, becoming a student of judo and jujutsu (a.k.a. jujitsu). Just as many far-seeing martial artists of the future (Bruce Lee) and past (Hua Yuan Ja), Barton-Wright realized that combining various arts would utilize the strengths in all and provide self-defense for the average "unarmed society."

He was among the first Europeans known to have studied the Japanese arts and teach them in Europe. He formed a Bartitsu (a combination of his name Bart and jujusu) Club in which both men and women could study various kinds of self defense, including hand-to-hand, jujutsu, Vigny cane fighting, boxing and Savate. The idea was to become proficient enough in each to be able to defend against all. This is similar to today's cross-training methods for fighters and the military service. Barton-Wright also had an unusual (for the time) pedagogical system whereby students were first required to attend private training sessions before being allowed into class groups.

He brought over several trainers from Japan to teach judo and jujutsu, Pierre Vigny himself to instruct in his la canne (stick fighting) style, a wrestler and those knowledgeable in fencing techniques. Practice was expanded to breathing exercises and boxing. Membership was allowed only after submission to review by a committee. During this time, Barton-Wright wrote articles for *Pearson's Magazine*. He was, unfortunately, a poor promoter, and the fame of his associates quickly eclipsed Bartitsu. Doors closed on the club in 1903.

Many of his employees, however, went on to open their own successful gyms in London. The Bartitsu Club was one of the first schools to offer classes to women, which was continued by instructors Yukio Tano and Sadakazu Uyenishi. Their student, Edith M. Garrud established her own jujutsu dojo and also taught to members of the militant Suffragette movement.
